

## **Acellories, Inc. WARRANTY**

Thank you for your interest in the products and services of Acellories, Inc.

This Limited Warranty applies to physical goods, and only for physical goods, purchased from Acellories, Inc., LLC. via Groupon (the "Physical Goods").

### **What does this limited warranty cover?**

This Limited Warranty covers any defects in material or workmanship under normal use during the Warranty Period. During the Warranty Period, Acellories, Inc. will repair or replace, at no charge, products or parts of a product that proves defective because of improper material or workmanship, under normal use and maintenance.

### **What will we do to correct problems?**

Acellories, Inc. will repair the Product at no charge, using new or refurbished replacement parts, or send out a replacement Product if the Product is beyond repair.

### **How long does the coverage last?**

The Warranty Period for Physical Goods purchased from Acellories, Inc. is 1 Year from the date of purchase.

A replacement Physical Good or part assumes the remaining warranty of the Original Physical Good or 1 Year from the date of replacement or repair, whichever is longer.

### **What does this limited warranty not cover?**

This Limited Warranty does not cover any problem that is caused by:

- Conditions, malfunctions or damage not resulting from defects in material or workmanship
- Conditions, malfunctions or damage (physical or otherwise) resulting from negligence, improper maintenance or modification-- damaged or destroyed by natural causes including but not limited to lightning, flood, or other natural disaster--- theft or loss of the Physical Goods.

### **What do you have to do?**

To obtain warranty service, you must first contact us to determine the problem and the most appropriate solution for you. Deliver the Physical Goods, in either its original packaging or packaging providing an equal degree of protection, including any accessories or documents that shipped with the Physical Goods to the address specified by Acellories, Inc.
