

Limited Lifetime U.S. Warranty

This limited warranty is provided by Amazon.com Services, Inc. to you as the original purchaser of the AmazonBasics-branded USB A Cable with Lightning Connector, Premium Collection cable(s) you purchased (the "Product"). We warrant the Product to you against defects in materials and workmanship under ordinary use for the lifetime of the Product. This limited warranty does not cover problems with your Product that were caused by accident, abuse, misuse, neglect, fire or exposure to heat, bright light, sun, liquids, sand or other contaminants, contact with cleaners or other chemicals, unauthorized use, alterations or repair, theft, or other external causes such as malfunction of other electronic equipment.

If the Product proves defective, and you follow the instructions that we will provide to you for returning the Product, we will, at our option, take one of the following actions: (i) replace the Product with either a new or a refurbished Product that is the same as or similar to the Product you purchased; (ii) repair the Product using either new or refurbished parts; or (iii) refund to you the purchase price of the Product. There is no assurance, representation or warranty that any replacement Product will be identical to or will offer the same functionalities as the Product returned to us.
