

Bragi – Refurbished Product - Limited Warranty (USA)

This Refurbished Product Limited Warranty (“Refurbished Warranty Policy”) applies to Bragi branded refurbished hardware products (“Refurbished Product(s)”) sold by Bragi GmbH and BRAGI STORE, LLC (“Bragi”). Bragi’s warranty obligations are to the original purchaser of the refurbished product (“you”) only and are limited to the terms set forth below. This Bragi Thirty-Day Limited Warranty is a voluntary manufacturer’s warranty. It provides rights separate to rights provided by consumer law, including but not limited to those relating to non-conforming goods. As such, the Bragi Ninety (90) Day Limited Warranty benefits are in addition to, and not instead of, rights provided by consumer law and it does not exclude, limit or suspend a buyer’s rights arising from consumer law.

LIMITED WARRANTY TERMS

Bragi provides the following limited warranty to you if you purchased the Refurbished Product(s) from Bragi, on Bragi’s website(s) (bragi.com and sub-websites), or if you purchased the Refurbished Product(s) from an authorized reseller. Bragi warrants that the Refurbished Product(s) will be free from material defects in materials and workmanship under normal use for a period of ninety (90) days from the date of your purchase (“Refurbished Warranty Period”). Your sole and exclusive remedies for warranty claims submitted to Bragi within the Refurbished Warranty Period pursuant to this Refurbished Warranty Policy are as follows: For all Refurbished Product(s) that fail the above warranty, Bragi will, at its sole option, either: (i) repair the Refurbished Product(s); (ii) replace the Refurbished Product(s) with a separate refurbished Product(s) (replacement Refurbished Product(s) being of identical model or functional equivalent); or (iii) provide to you a refund in the amount of the price you paid for the Refurbished Product(s) (excluding taxes and shipping costs); and Any Refurbished Product(s) that have been repaired or replaced under this Refurbished Warranty Policy will have warranty coverage for the longer of: (a) thirty (30) days from the date of repair or replacement; or (b) the remaining original Warranty Period. Replacement parts used in the repair of the Refurbished Product(s) may be new, equivalent to new, or refurbished.

TO OBTAIN WARRANTY SERVICE FROM BRAGI:

To obtain warranty service, contact our Bragi Support for shipping instructions and an RMA tracking number. Securely pack the Refurbished Product and a copy of the original sales receipt, which is required as a proof of purchase for warranty repairs. Write or print out the tracking number and affix it to the outside of the package. Send the Refurbished Product, freight charges prepaid by you the customer, to the dedicated/nearest warranty service station.

This Refurbished Warranty Policy applies only to Refurbished Product(s) manufactured by or for Bragi that are marked with the “Bragi” trade name or logo and contain a valid Bragi serial number which has not been removed or altered.

This Refurbished Warranty Policy does not apply to, and specifically excludes, the following: (a) consumable parts and accessories, such as FitSleeve parts, The Leash accessory, and others; (b) normal wear and tear and cosmetic damage, including, but not limited to, scratches, dents and broken plastic; (c) defects or damage caused by misuse, accident (including, without limitation, collision, fire and the spillage of food or liquid), neglect, abuse, alteration, unusual stress, modification, improper or unauthorized repair, installation, wiring, or testing, improper storage, third-party applications downloaded to the Refurbished Product(s) or companion applications that connect to and communicate with the Refurbished Product(s) or if any of the serial numbers have been removed or altered; (d) damage caused by operating the Refurbished Product(s) outside the permitted or intended uses described by Bragi; (e) damage caused by use with non-Bragi products; (f) any non-Bragi hardware products or any software, even if packaged or sold with the Refurbished Product(s); and (g) modifications of the Refurbished Product(s) firmware or software by anyone other than Bragi. Bragi reserves the right to disable Refurbished Product(s) if Bragi suspects fraud or if Bragi determines that the Refurbished Product(s) are counterfeit, stolen or lost in shipment.

Bragi does not warrant that the operation of the Refurbished Product(s) will be uninterrupted or error-free. Bragi is not responsible for damage arising from failure to follow instructions relating to the use of the Product(s).

Your sole and exclusive remedies for warranty claims submitted to Bragi within the Refurbished Warranty Period pursuant to this Warranty Policy are as follows:

For all Refurbished Product(s) that fail the above warranty, Bragi will, at its sole option, either: (i) repair the Refurbished Product(s); (ii) replace the Refurbished Product(s) with a separate refurbished Product(s) (replacement Refurbished Product(s) being of identical model or functional equivalent); or (iii) provide to
