PRODUCT DESCRIPTION

Our Dried Apricots are harvested at the peak of ripeness for full flavor, halved or whole with pits removed, sulfured to retain color and sun dried in the Central Coast of California. Inspected to meet USDA Standards and quality that our customers deserve.

COLOR / FLAVOR

Mostly uniform golden orange characteristic of sun-dried apricots with sweet tart intense flavor.

SIZE AND STYLE

Fancy Halves - Sized according to USDA Grade Standards 1-1/8" to 1-1/4" Dia.

ANALYTICAL

Sulfur: 1600 – 2500 ppm
Moisture: 23% - 28%

- Completely free from dirt and foreign material. May contain occasional pit fragments.
- Metal Detection:

Stainless Steel: < 1.5 mm
Ferrous Iron: < 1.0 mm
Non-Ferrous Iron: <1.0 mm
