- 2. **DAMAGE AND LIABILITY LIMITATION**. Under no circumstances shall the Company be liable for any lost profits or other incidental or consequential damages of any kind for any reason whatsoever with respect to its Products, or the transaction by which its Products are sold. As clearly stated in the FAQ, Safe-T is a fully functioning fire extinguishing device, manufactured with the highest safety standards and CE certified. Nevertheless, you acknowledge that Safe-T is not made to replace your official fire extinguisher, the first recourse in case of a fire. Safe-T is a decorative fire extinguisher and the Company makes no claim as to its effectiveness in case of a fire.
- 3. **GOVERNING LAW**. The transaction with respect to the goods which are the subject of this online sale shall exclusively and irrevocably be between the Company and the purchaser of the product and governed by and interpreted and constructed in accordance with the laws of the State of Florida, and any action arising out of such transaction shall be brought exclusively in courts seated in Palm Beach County and Buyers agreement to such exclusive jurisdiction and venue is a condition of sale.
